Comments by the authors: We performed this study because we think that we must help people with a long-standing therapy-resistant CRPS-I. CRPS-I usually requires long, intensive treatment in accordance with guidelines. For a minority of these people treatment does not reduce or resolve pain. The affected limb may become dysfunctional and can prevent participation in the daily life. Amputation as a last resort treatment is still a topic for heated debates among physicians. The first people were amputated by us as a last-resort treatment in the early nineties of the last century. We showed that amputation can be an effective treatment in selected cases.. Read more

Comments by the authors: Understanding the neuronal changes after a spinal cord injury is essential for understanding the mechanisms behind recovery. The neuronal overactivity in the spinal cord that develops after a spinal cord injury can possibly be one of these mechanisms. It is important to identify the overactive neurons in order to target them for interventions. The present work is a first step to find out the segmental level of these overactive neurones. We tried to solve this by investigating how the lesion level affects the occurrence of two types of neuronal overactivity. spasticity and below level spinal cord injury neuropathic pain.
